## Extract: From South East Statement of Rules

**4.1.2.** Any other club seeking to participate in the competitions conducted by the League may do so provided the club satisfies the Board of the following, namely that:

- (a) It is incorporated pursuant to the *Associations Incorporation Act 1981* or it is a company incorporated pursuant to the *Corporations Act*;
- (b) Its application will comply with and satisfy AFL Victoria requirements for transfer of clubs between Leagues;
- (c) Its facilities and financial circumstances are of a standard acceptable to the Board;
- (d) Its name and uniform are acceptable to the Board or will be altered to a uniform acceptable to the Board;
- (e) It was a financial member for the previous season of the previous league or association with which it was affiliated (if applicable);
- (f) It is willing to pay a security bond as determined by the Board upon being accepted into the League;
- (g) It is willing to pay an acceptance fee as determined by the Board;
- (h) It can demonstrate that it has access to and approval to use a facility suitable for the use of Australian Football during the period 1 April to 30 September each year and;
- (i) **Applications for membership are received by;**
  - (a) **Existing clubs:** 15 September in any given year
  - (b) **New established Clubs:** may apply in writing by 30 October in any given year
  - (c) **Existing Clubs:** Clubs who are affiliated with another AFL Victoria League may apply for Membership to field teams in the South East Juniors by March 1<sup>st</sup> in any given year.

**4.1.3** In exceptional circumstances the South East Juniors General Manager may waive the club deadline outlined in clause (i) b or c at his or her absolute discretion.

**4.1.4** All applications by clubs wishing to become a Club Member will be voted on by the Board.

**4.1.5** All Club Members must hold their Annual General Meeting prior to 30 November each year.

**4.1.6** Each Club Member agrees to be bound by the Rules, By-Laws, determinations and decisions of the League, for itself, its Officials and Registered Players.
